ORDINANCE 2026-08

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE
2026 APPROPRIATION AND DECLARING AN EMERGENCY.**

WHEREAS, Section 5705.40 of the Ohio Revised Code provides for the transfer from one appropriation to another; and

WHEREAS, the Village of Mantua received a grant from the Ohio Department of Natural Resources (ODNR) for financial assistance through the State of Ohio H2Ohio Grant Program for the Mats Road Bridge Project in the amount of \$263,290.00;

WHEREAS, the grant monies have been deposited into Road and Bridge Fund #2012; and

WHEREAS, pursuant the Ordinance 2026-07, the Village established a fund for the project, known as the Mats Road Bridge Project Fund #2062; and

WHEREAS, appropriations in the amount of \$263,290.00 for the Mats Road Bridge removal project are required to be transferred from the Road and Bridge Fund #2012 to the Mats Road Bridge Project Fund #2062; and

WHEREAS, additional appropriations in the General Fund #1000 shall be increased in the total amount of \$ 75,254.00 for the purchase of Ford F600; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. The Fiscal Officer is hereby authorized and directed to transfer appropriations in the amount of \$263,290.00 from the Road and Bridge Fund # 2012 to the Mats Road Bridge Project Fund # 2062 for the purposes of funding the Mats Road Bridge removal project.

SECTION 2. Council does hereby authorize the following adjustments to the 2026 Village of Mantua Appropriations:
